General Rules / Instructions

- Language is not assessed for merit. Participants can express their views in English / Malayalam.
- Eligibility: Any UG & PG Students or Research scholars can register
- Interested teams shall ensure entry to the programme by filling and submitting google forms provided herewith along with payment receipt.
- A maximum of two teams can participate from an institution.
- Participants should produce a valid ID card from their institution
- A panel of eminent judges shall officiate the competition. The decision of judges will be final.

- Date of Competition: March 28, 2023
- Registration closes on: March 25, 2023

Note: All participants must ensure their presence by 9: 30 AM on the date of competition

Venue: School of Indian Legal Thought Kottayam



About the Round

- There will be only one round, from which top three teams and the best debater will be selected.
- There shall be two members in one team. The debate will be between the team members itself. One speaking for the motion and one against the motion

Time limit:

- Each team will be allotted with 10 minutes for their arguments. This time can be divided between the team members at their ease. A warning bell will be given after 8 minutes and a final bell after 10 minutes. If the participants exceed the allocated time then the marks will be deducted at the discretion of the judges.

Marking criteria

- The debate will be evaluated on the basis of content, body language, confidence, coherence and flow. Language skills will not be a parameter of assessment.

Fee and Return Policy

- Registration fee - 500 per team
- The registration fees will not be refunded.

Maximum number of teams

- The maximum number of teams for the competition is limited to 20. The admission of registration will be on 'first come first serve' basis.

Miscellaneous

- The decision of the judges as regards the result of the competition will be the final and binding
- All participants are expected to maintain decorum in the hall where the event will be held
- The organizers reserve the right to take appropriate action for any unethical, unprofessional and immoral conduct
- The organizer's decision regarding interpretation of rules or any other matter related to competition will be final
- If there is any situation not contemplated in the rules, the decision of the Institute shall be final.
